Special Joint Meeting with Parks Committee Minutes
May 19, 2022

The Board of Trustees of Pierce Township, Clermont County, Ohio met for a Special Joint Meeting with Parks Committee at 5:00p.m., Wednesday, May 19 2022 at the Pierce Township Administration Building, 950 Locust Corner Road.
