	<b>Park Improvements</b>
1.1	<p>Master Plan Updates:</p> <ul style="list-style-type: none"> <li>• The group will target May or June for draft to the Trustees. Loretta suggested a joint work session with the Trustees. In the work session, the group needs to address the future First Responder Memorial.</li> <li>• Doug has started on the narrative and Pat has forwarded screenshots of the parks from the Auditor’s website. Loretta suggested adding the County’s 10 Mile Preserve as an amenity.</li> <li>• George suggested there be a map of the Township with the Parks pinned. Loretta stated that Eddie McCarthy may be able to help with this.</li> <li>• Doug has tried to call Wayne Harris with NOPE but hasn’t heard back. Doug will reach out to Allen Freeman.</li> <li>• Randy stated that the Tree Program is in progress.</li> </ul>
1.2	<p>Clermont County Parks Grant: Loretta stated that the Township’s application for the ballfield fencing may not be approved based on feedback from the County, but, there is nothing official. She did say that their appears to be funding for the 10 Mile Preserve which is a County park in Pierce.</p>
1.3	<p>Locust Corner Park Playground Equipment: The climbing replacement has been ordered, but, we’re not sure on lead time and have not received official confirmation.</p>
1.4	<p>History Trail: George has provided a draft for the Amelia history sign. Lori was able to find photos from the Clermont County Historical Society. Urban Signs has provided pricing for 12x18 signs at \$17/SF. Sherman Signs in Amelia is working on pricing. George and John are to meet Friday, 03/05/2021 in the Park to discuss installation of the pedestals.</p>
1.5	<p>Amelia Park Signs: Trustees have approved new signs for the Amelia Parks. Mark Cann had provided the contact for Sherman Signs in Amelia. Loretta is to follow up and send information to Laura and John to place the order with Sherman Signs.</p>
